This combined Accredited AAMET International 3 day Course includes Foundational Level 1 and Practitioner Level 2 working towards Practitioner Certification status with Pre and Post study.

Training consists of the minimum of 12 hours training at Foundational Level 1 with Practical Training and Theory. This is a one day course including Pre and Post Course study and assignments making up 12 hours in total.

Practitioner Level 2 is a two day course of 12 hours working towards Practitioner certification.

Total course work combined of 24 hours.

Training Stage 1. Level 1 & 2 Coursework £495.00

- Pre Course Study and Assignments
- Foundational Level 1 one day course (pre requisite of Practitioner Course)
- Foundational Level 1 Training Manual issued
- Practitioner Level 2 two day course (combined with Level 1 for a 3 day course)
- Practitioner Training Manual Level 2 issued

- Discuss Post study and assignment requirements as part of course
- Discuss Post Course requirements, case studies, practice hours, supervision & exam

Training Stage 2. Post Practitioner course

- Following successful completion of the above Training Stage 1
- AAMET Administration forms issued for CPDs, Supervision and Practice hours
- Post Course study and Assignment Assessment, feedback
- Assessments of 4 x Case studies (one may be a self-study session)
- 6 hours Supervision with your trainer
- Total of 50 practice hours with at least 20 individuals with sessions of 45 minutes (or longer)
- Evaluation, feedback and assessment of one 'live' EFT session either in person or video.
- Follow up and discussion of this 'live' session with trainer.

Training Stage 3. Certification

- Competency self - assessment & trainer competency assessment documents at both levels
- Register as an AAMET student on the AAMET website which is currently £15 payable to AAMET and complete the On Multi Choice Exam £10 payable to AMMET fees as at 1/2/2016
- 3 attempts of the Exam are allowed. If at any stage unsuccessful in completing the pass rate, coaching, advice or further training will be undertaken without further cost.
- On successful completion to trainer's requirements and standards of all above a Practitioner Certificate is issued at Level 2.

NB:

On occasions a Trainer may ask for additional case studies, practice or assignments at any stage to reasonably help students achieve progress and standards towards professional certification.

Following Practitioner Certification:

AAMET requires that Practitioners maintain their professional status with 6 hours per annum Supervision with an official supervisor and 30 hours CPDs.

Once a student has passed the exam, had their case studies accepted, attended the required supervision and received an email from their trainer confirming their new status, they can upgrade to their full AAMET member status from student via the AAMET International website on payment of an annual fee of £30

Fees:

Training Stage 1. 3 day course including Pre Course study **£495.00**

Training Stage 2. 6 hours Supervision, assessing case studies and evaluating one session video or live with feedback, support and post course study and assignment assessment. **£350.00**

Training Stage 3. Some follow up or further training may be required dependent on the exam but this is at **No Trainers Fee £00.00**

Making Payments:

There are several flexible payment options:

- Payment made in full of Training Stage 1 & 2 at a reduced rate of **£800.00** offering a student discount of £40.00 **Normally £845.00**
- Two separate payments at Training Stage 1 & 2.
 - 1) Training Stage 1.
One payment of **£495.00** with a **£95.00 deposit** required
The **balance of £400.00** required a week before the course
OR payment in full at this stage of **£495.00**
 - 2) Training Stage 2.
Second payment of **£350.00** required when student is ready to proceed. This can be paid in two payments if preferred.
